A New Name. A Broader Vision. The Same Commitment to Caring

From the first day in July 1997, when Putnam Family and Community Services transitioned from being a county-run Putnam Family & Communi Services agency to a private non-profit organization, we have fostered hope, wellness, and recovery for people in the Lower Hudson Center Valley. In 2017, twenty years later, we made the decision 2017 under our strategic plan to transform once more: we changed our name to CoveCare Center. We wanted a new name that reflected the essence of our values and mission, and our renewed commitment to serving those in need of our services throughout the Lower Hudson Valley.

The name "Putnam Family and Community Services (PFCS)" had long created confusion: people routinely mistook the agency for the state-run Putnam Community Services (PCS) and other similarly named agencies. Many people assumed we were still a government agency, or believed that we served only residents of Putnam County rather than the entire Lower Hudson Valley and Western Connecticut. Finally, our name did not effectively communicate what services we provide and our passion for caring for those we serve.

The name "CoveCare Center" and our new logo depict the safe harbor we offer to our clients. We believe that it conveys our unwavering commitment to caring for everyone we serve, and the warm welcome we extend to the entire community. After all, "Cove" is at the very heart of "Recovery."

MENTAL HEALTH COUNSELING & TREATMENT SERVICES

Licensed therapists provide individual, group, and family therapy, as well as play therapy for children. As a supplement to therapy, psychiatrists prescribe and manage medications when needed, and trained peer specialists provide guidance and support based on their lived experiences.

2017 HIGHLIGHTS

- Accessibility of Mental Health Treatment services in Putnam County expanded through establishment of three satellite locations including St. Christopher's in Garrison and CareMount Medical sites in Patterson and Brewster.
- Psychiatric Nurse Practitioner added to staff in order to fill the increasing demand for psychiatric support.
- A new Electronic Health Record system implemented to facilitate better management of client records, integrated treatment plans, and scheduling

COMMUNITY-BASED SERVICES ADULT CARE

CoveCare Center Care Managers serve as partners to and advocates for adults with mental health, medical, and/or substance use issues who need help finding and navigating the many service systems that may help them to: access care; find transportation; obtain housing; access temporary assistance and food; live independently; obtain insurance, benefits and entitlements; and so much more. Seniors benefit from home-based counseling and referrals.

2017 HIGHLIGHTS

- Senior Partnership Services program launched under a 5-year grant from the Office of Mental Health, providing mobile behavioral health support services for Putnam residents ages 55+.
- A Peer Specialist position was incorporated into our Health Home Care Management program, which increased home and community visits and added an element of lived mental health experience to our care management services.
- We were able to engage and/or assess 5.5 times more clients for Home and Community Based Services (HCBS) than in 2016.

COMMUNITY-BASED SERVICES FAMILIES AND CHILDREN

Children with mental health, substance use, medical, and other needs - and their parents/caregivers – receive assistance that includes navigating service delivery systems, peer support, and advocacy. Parents become strengthened through parenting skills trainings, family support groups, supervised visitation and counseling.

2017 HIGHLIGHTS

- Children's Community-Based Services became a separate, distinct department due to the increasing demand for services and the diversity of the programs offered for families and children.
- Children's Health Home Care Management began operations in January 2017, providing services to a wider range of individuals. An additional Case Manager was added to support the demand.
- CCSI Case Management case load increased by 15% in 2017 in order to serve non-Medicaid clients who could not otherwise be served in the Health Home program.

Credentialed counselors and social workers provide individual, family, and group counseling. Psychiatrists provide evaluations and prescribe medications, including treatment for opioid use. CoveCare Center offers prevention education in Putnam County schools, raises awareness about substance use issues, and informs the public about local resources.

ALCOHOL AND SUBSTANCE USE TREATMENT AND PREVENTION

2017 HIGHLIGHTS

• CoveCare was awarded one of 10 statewide grants to establish a Family Support Navigator program to help families and individuals struggling with substance use disorders.

• The Medication Assisted Treatment Program was fully implemented for clients with a history of opioid use who need prescribed medication to manage this disorder. The program includes groups, individual counseling, and doctor visits for medication.

• Co-sponsored the "Reversing the Stigma" event to address the issues of substance use. It was attended by approximately 150 community members.

PROSper PERSONALIZED RECOVERY-ORIENTED SERVICES

PROSper helps people with serious mental health issues to recover, heal, and gain their independence. Services include goal-oriented counseling, classes, individual counseling, medication management, vocational counseling, and specialized services for people with both mental health and substance use

2017 HIGHLIGHTS

• PROS received an Honorable Mention in Substance Abuse and Mental Health Services Administration's (SAMHSA) 2017 Recognition of Excellence in Wellness Initiative. The national Million Hearts Initiative is to prevent heart disease and stroke.

 96% of discharged PROS clients reported that they would recommend PROS services to others.

• PROS averaged 31% of its population engaged in paid, competitive employment.

2017 Partnership Launches: CareMount Medical & St. Christopher's



In 2017, CoveCare Center and CareMount Medical entered into an innovative new partnership that allows us to unite physical and behavioral health services and promote a model for integrated care.

CoveCare Center therapists now provide mental health counseling and treatment directly at CareMount Medical locations in Brewster and Patterson, based on a referral and 'warm hand-off' from a CareMount Medical physician. This collaborative approach to treatment for those who experience physical health conditions, in addition to mental health and/or substance use issues, is fully aligned with recent New York State guidelines, and CoveCare and CareMount Medical are leading the way. With increased communication and coordination between their health care

professionals, those in need are treated in a more comprehensive and effective way. This approach improves overall quality of care by addressing the whole person, while also reducing costs.

"Our mission has always been to offer the highest quality and most effective care to all of our patients, and partnering with CoveCare Center allows us to more thoroughly treat the entire patient. Mental health is an important part of a person's physical health," said Scott D. Hayworth, M.D., President and CEO, CareMount Medical. "This partnership helps to fulfill a major goal for CareMount Medical - to help our patients obtain easy access to quality mental health services."

In addition, CoveCare has partnered with St. Christopher's Inn in Garrison to provide on-site mental health counseling to residents in St. Christopher's rehabilitation programs, ensuring that St. Christopher's can meet its commitment to provide quality health care that addresses all facets of physical, emotional and spiritual healing.

Ensuring Continuity and Growth of Mental Health Services through Affiliation

CoveCare Center and the Mental Health Association in Putnam (MHA) collaborated throughout 2017 to lay the groundwork for an affiliation that leverages the strength of both organizations, with the goal to continue and grow the robust mental health services available to residents of Putnam and neighboring counties. A partnership officially launched on January 1, 2018. MHA continues to provide its valuable services and supports, offered since their 1993 inception, in an independent, sustainable fashion. These services complement the broad base of mental health and substance use treatment and prevention services available at CoveCare Center.



CoveCare Center and MHA in Putnam, leaders in the provision of mental health services, will each maintain their own 501(c) (3) status. By formalizing their long-standing partnership through affiliation, MHA continues as a vital resource in Putnam County, particularly in the areas of peer support, community education, and outreach with an emphasis on suicide prevention and veterans. CoveCare Center continues to work closely with MHA in those areas while still providing caring, compassionate, and confidential treatment for those who need assistance with mental health, substance use, and emotional and social issues.

Megan Castellano, Executive Director of MHA notes, "We are so excited about this opportunity which will allow us to expand the scope of our services while also providing us with the administrative infrastructure that we need to be a service provider long into the future. Through this strategic restructuring initiative, we can continue to focus on providing support to those in need where we live and work, right here in Putnam County."




